I hereby assume any and all risk associated with Equine activities, Hunting, and Shooting as well as all other activities at Catskill Pheasantry LLC, Long Eddy, NY. I know that these activities are considered to be dangerous activities, and hereby assume all risk of any and all injuries I may suffer due to the grounds or physical condition of Catskill Pheasantry LLC, the acts or omissions of other hunters or shooters who may be on or near Catskill Pheasantry LLC whether with or without permission, equipment failures, acts of god, and/or for any other reason.

I understand that there will likely be other persons hunting and/or shooting at Catskill Pheasantry LLC and I agree to act prudently and carefully to avoid causing them any injury. In the event that I am involved in an accident and cause injury to any person, dog handler or dog I will take full responsibility for my actions. I am aware that the cost of a fully trained bird dog could be at least five thousand dollars. In the event that I shoot a dog, I will pay to replace the dog and cover all veterinary bills that are incurred. I certify that I am familiar with the use and operation of the firearm(s) I will be using while at Catskill Pheasantry LLC and that I am familiar with the rules of hunting, shooting and firearm safety.

I understand that the drinking of alcohol before or during hunting or shooting is not permitted at Catskill Pheasantry LLC.

I am aware that it is my responsibility to provide eye and ear protection while shooting and participating in any activity while I am at the Catskill Pheasantry LLC. I also understand that I am required to provide and wear hunter orange clothing while hunting. Guidelines are to follow those provided by the state of New York.

I hereby release Catskill Pheasantry LLC together with all owners, members, employees, agents and representatives for any and all personal injury and/or property damage which may arise as result of my presence at Catskill Pheasantry LLC. I give this release and assume all risks for all activities including shooting, horseback riding, and hunting at Catskill Pheasantry LLC.
